

GENERAL RULES

DISCIPLINE:

- 1. Every bonafide student of the college must wear his/her Identity Card at all times when he/she is in the college premises. Student without Identity Card is liable to be fined.
- 2. Students must not attend classes other than their own without the special permission of the professor concerned.
- 3. In case of no lectures, students should not loiter in the corridors.
- 4. Smoking is strictly prohibited in the College premises.
- 5. Use of mobile phones is strictly prohibited in the College campus.
- 6. Disobedience, misconduct or misbehaviour or failure to comply with any one or more of the rules, regulations and requirements, notified from time to time, will result in the imposition of fines, loss of terms, suspension, dismissal or any other disciplinary action.
- 7. Students must not directly and indirectly act in a manner which is likely to be detrimental to the working of the college or to the interest of the students or to the maintenance of discipline.
- 8. Students should not cause any damage to college property and are expected to take care of it.
- 9. Students should not invite any outsider to the college premises.
- 10. No fund collection should be made by any student without prior written permission of the Principal.
- 11. Students are advised not to leave their belongings unattended. The college is not responsible for any loss of or damage to, the articles or valuables of the students.
- 12. The Principal has the power to determine the suitable disciplinary action, for maintaining discipline and proper conduct of the students of the college.
- 13. Parents/Guardians are requested to go through the rules of conduct and discipline while allowing their son/daughter/ward to join the college. At the time of admission on behalf of the students-the parents/guardians will have to submit an undertaking on a prescribed form issued by the College.
- 14. Matters not covered by the existing rules will rest at the absolute discretion of the Principal.

ATTENDANCE:

- 1. Attendance in all classes (i.e. lectures, tutorials etc.) is compulsory, Absence from any one of them will be taken as absence for the whole day.
- 2. A student who is not able to attend his classes/lectures/tutorials for a long period should take prior permission for such absence from the Principal of the college.
- 3. A student whose attendance in a term is not satisfactory may not be allowed to appear for the examination.

INFRASTRUCTURE

LIBRARY

The college Library is spread over an area of 3748 sq.ft. and situated on the fourth floor of the college building. It has a vast collection of nearly 30,000 books of various disciplines. The Library subscribes to nearly 13 newspapers, 25 magazines and academic journals on a regular basis. For easy accessibility and reference the students make use of the **KOHA Library Software** and can locate any book, journal, magazine etc., at the flick of a button.

The Library is very students friendly, having spacious seating arrangement and is open from 9.30 a.m. in the morning to 5.00 p.m. in the evening.

LIBRARY RULES

- 1. Students visiting the library must have valid identity cards.
- 2. Reference material from the Reference section will be provided to students on production of identity cards for reading in the library premises only. Incase of failure to return the material on the same day, the students is liable to pay fine of Rs. 5/- per day.
- 3. Absolute silence must be maintained in the library.
- 4. Use of mobile phones is strictly prohibited in the library.
- 5. Reader's tickets will be issued to members only.
- 6. Two books at a time will be issued for home reading, one Text Book and another Reference Book.
- 7. Books will be issued to members between 9.30 a.m. to 5.00p.m. on all working days.
- 8. Every book borrowed for home reading must be returned to the library on or before the date marked on the due-date slip. A fine of Rs. 5/- per day will be charged incase of late return.
- 9. Students are expected to handle books and magazines with care. Any damage to the books will result in imposition of fine.

THE COMPUTER LAB

The demand of the twenty first century requires that the new generation be computer savvy. Keeping in mind the various courses, subjects like Information Technology (IT) and Computer Systems and Application which are conducted in the college.

The college prides itself in having 3 computer laboratories with latest software and hardware configuration which has been installed to cater to the needs of the students in compliance with the designed syllabi.

GYMNASIUM

The latest addition to the college infrastructure is the air conditioned state of the art gymnasium. Situated on the ground floor of the college building, it boasts of the latest gadgets and equipments...be it the motorized treadmill, the abdomen bench, the shoulder press or the magnetic cycle, free weights or the leg curl-all latest gadgets to keep one physically fit.

- Criteria: Parents income bracket more than Rs. 1,00,000/-
- Students belonging to the following categories are eligible for SCHOLARSHIPS: S.C./S.T./O.B.C./ D.T./N.T. and Special Backward Class (S.B.C.).
- Students should apply for the same at the time of admissions.

COLLEGE AWARDS AND PRIZES

- The Lions Club of Malad-Borivali College Charity Trust (The governing body of the college) awards every
 year prizes to the student standing First, Second and Third amongst the student of the college at the F.Y.J.C.
 & S.Y.J.C. Commerce Examination conducted by the College & Board.
- The Gold Medals for the Best Boy & Best Girl is awarded on the basis of student's progress in studies, games, co-curricular activities, inter collegiate achievements and conduct.

EXAMINATION & RESULTS

- All rules of the MAHARASHTRA STATE BOARD OF SECONDARY AND HIGHER SECONDARY EDUCATION applicable and binding to the students.
- Rule of Promotion for finalising the result of First Year of Junior College (Higher Secondary Std. XI) Examination.
- At the time of examination no student shall remain absent from the college without the permission of the Principal. In the case of absence due to illness, a medical certificate must be submitted as soon as possible.
- Re-examination will be conducted only in genuine medical cases and only for the term exams. There will be no-examination for unit tests.
- The Examinations are held as per the Rules, Regulations and Guidelines set by the Maharashtra State Board of Secondary and Higher Secondary Education, Pune. The examination pattern is subject to change from time to time, the same will be informed to the students accordingly.
- A candidate must secure minimum 35 marks out of 100 in each subject.
- Marks for Theory and ABT(Application Based Test), practical/oral in the subject where there are two parts, will be taken together and the total marks will be considered for a passing or distinction.
- The result of the First Year Junior College (Std. XI) class is not decided on the marks obtained only in the second term end examination. Equal weightage is given to; First Term End Examination, Second Term End Examination and Year's Work-Practical, Unit-Tests, ABT, Orals etc. and the final result of the student for each subject is decided on the average marks (a+b)/2only.
- If a candidate appearing in all subjects and fails in one or more subjects, his/her deficiency of marks in any 3 subjects, up to a maximum of 15 marks (not exceeding 5 marks in any one subject) shall be condoned for the purpose of passing the examination.
- Although maximum 5 marks condonation is to be given in one subject such concession shall not exceed the required minimum percentage of passing in subject i.e.35%
- No candidate shall be promoted to the next higher standard if the candidate fails even after applying the condonation of deficiency rule.
- There shall not be re-examination in the case of students who have failed.
- In the case of students who could not appear at the first or second term end examination for genuine reasons, due to ill health (on providing of a medical certificate in time) or such other reasons beyond his/her control (such as natural calamities), the Head of the Junior college shall hold the re-exams for the same.
- Health & Physical Education and Environment Education & Water Security are made a compulsory subject at Junior College by H.S.C. Board. Student's grade will be included in the H.S.C. result. Minimum 'C' grade is required to get through this subject at H.S.C. level.

ELIGIBILITY OF REGULAR CANDIDATES FOR ALLOWING TO APPEAR FOR H.S.C. EXAMINATION

A candidate attending the second year of junior college class shall be eligible to appear for the Higher Secondary Certificate examination to be held at the end of the second year of junior college on full filling the following conditions.

1. (a) In the case of the Feb / March examination, the should have attended Second Year Junior College for not less than 75% of working days, during the period from the opening day of the academic year to the 11th of February of following year.

Provided that:-

- (i) The said 75 per cent attendance is kept by candidate separately during the academic year, both before and after his form of application for admission to the examination is forwarded by the head of the junior college concerned.
- (ii) A candidate who has kept the required minimum attendance of 75% of the total working days during the period of the academic year preceding the date of forwarding the application for admission to the examination but who did not submit his application for admission to the examination or whose application was withdrawn under Regulation 93(8) for the examination to be held at the end of the academic year shall complete, the minimum attendance prescribed under this clause either:-
- A during the remaining part of the same academic year or,
- **B** during the first term of the next academic year if he intends to appear at the examination in the following June or July, or
- **C** during the second terms of the next academic year if he intends to appear at the examination in the following March or April
 - **(b)** The Divisional Chairman, may for special medical reasons or circumstances beyond the control of the candidate as certified by the head of the institution, condone a deficiency in the percentage of attendance prescribed under clause (a) above upto 15 percent.
 - (c) The head of the Junior College concerned shall under Regulation 93(8) on or before the prescribed therein, forms of applications forwarded to the Divisional Board's Office in respect of those candidates who do not fulfil the conditions laid down under clause (1) and (ii) of the provision to clause (A) above, unless the deficiency in attendance is condoned by the Divisional Chairman in cases referred to him by the head of the Junior College with a statement of each such candidate in the form prescribed by the Divisional Board.
- 2. The Head of the Junior College has certified that:
 - (a) The student had kept the prescribed attendance as laid down clause (1) (a) above.
 - (b) To the best of his knowledge, the candidate is a fit person as regards character for admission to the examination, where in the opinion of the Junior College, the character of any candidate is not good, he shall nevertheless forward the application of the candidate to the divisional board after endorsing thereon the

reason for forming such opinion, with the instance (if any) in support thereof. All such applications shall be considered by the Standing Committee, which shall, on merits or each case, decide whether the candidate be permitted to appear at the examination or not, and the decision of the Standing Committee shall be final.

- **3.** Every candidate attending second year of Junior College Class makes a proper application to the Divisional Board for appearing at the examination if he/she satisfies the conditions laid down in this Regulation regarding attendance and completing practical work (if any) and if the head of Junior College certified that he/she is a fit person as regard character for admission to the examination or where such certificate is not given the Standing Committee decides that the candidate be permitted to appear at the examination, then such candidate shall have a right to be admitted to and appear at the examination.
- **4.** Where a proper application is made by the candidate to the Divisional Board for appearing at the examination, and the conditions regarding attendance and completing practical work (if any) are satisfied, the application shall not be with held by the head of the Junior College on any other ground.
- **5.** Every candidate (whether Private or Regular) shall abide by the instruction which the Divisional Board may, from time to time issue through the heads of Junior College regarding submission of application forms, admission to the examination hall and discipline during the course of the examination, any breach of such instructions will render a candidate liable for action under Regulation 91.

APPLICATIONS FOR THE EXAMINATION:

6. All applications for permission to withdraw forms of applications for admission to the examination forwarded under Clauses (1) and (2) above shall be submitted by the head of the Junior College concerned so as to reach the Divisional Board's office.

Provided that, it shall be competent for the Divisional Chairman to allow withdrawals of applications ever after the last dates mentioned under Clause (8) above, in special cases on the merits of each case, but no refund examination fees already paid by the candidates in such cases shall be held admissible if a Seat No. has already been assigned to the candidate concerned by the Divisional Board's Office.


