GUEST LECTURE

Guest Lecture on Intellectual Property Rights was conducted on 11th January 2020 by Dr. Deepa Chitnis (Associate Professor N.M. College of Commerce and Economics Vile Parle) on 11th January 2020.

COURT VISIT

The purpose of the visit was to understand the working of a court, the nature of duties of the judicial officers. The visit was to help the student in understanding the role of court in dispensing justice in any case, the role of prosecutors in a case, the way cases proceed in a court, the way judges, prosecutors and defence lawyers handle the case, the relationship of the prosecutors and the police. This gave an opportunity to understand the actual need of co- ordination in the justice system. The visit included an in-depth study of the day to day functioning of the Civil and Criminal Courts, at different levels and over a vast variety of cases including corporate matters. The aim was to evaluate the resources available and the distribution of power between the judges, the prosecution, and the defence council.

150 students of S.Y.B.Com visited the Hon'ble Bombay High Court, on 29th January, 2020. The students were accompanied by Dr. Mahendra Pachadkar Assistant Professor- Department of Business Law

The visit was permitted by Registrar Bombay High Court, which was obtained by Dr. Mahendra Pachadkar the day started with a brief note given to the students about the Court and court rooms by Advocate Chetan Satpute who is practicing Advocate at Bombay High Court, Faridabad. He guided all the students and dictated the Jurisdiction of the different courts.

The Feedback given by students indicated that students had the curiosity of court proceedings which they have seen in presence and acquired the basic knowledge about the court and judicial system.



DEBATE SESSION ON CAA V/S NRC:

A debate on Citizenship Amendment Act V/s The National Register of Citizens (NRC) was held on 22nd January 2020. CAA is the Citizenship Amendment Act (Bill) protests, also known as CAA Protest or CAB Protest, occurred after the Citizenship Amendment Act (CAA) was enacted by the Government of India on 12 December 2019 and NRC is a register of all Indian citizens whose creation is mandated by the 2003 amendment of the Citizenship Act, 1955. Its purpose is to document all the legal citizens of India so that the illegal migrants can be identified and deported. These are the burning issues nowadays. Hence two different groups were formed in favour and against view in respect of CAA and NRC. A healthy discussion and debate had been conducted amongst the students and a strong outcome had been drawn out of it. Dr. Mahendra Pachadkar .
