Option A:

1. Visit on <https://mu.samarth.edu.in/index.php/dashboard>
2. Signing With Portal -> Student Portal
3. Enter Your User Id -> Example (MU034112025XXXXXXX)
4. Enter Your Password -> Example (XXXXXX)
5. Click on -> Announcement.
6. Click on -> Click here to Link / Create Your ABC Account.
7. Fill all necessary details and click on verify.

After doing all process you get message i.e Your ABC account has been successfully linked.

You are required to complete the process as per the date mentioned above, failing which you will not be allowed to appear for any examination.

Note: - If not generated, then your degree and marksheets will not be seen on your Student Portal and digi locker.

Subject : Linking of Students' ABC IDs – Compliance by 24th December, 2025

All Principals of Affiliated Colleges, Principals of Autonomous Colleges, Directors of Recognized Institutions, Heads of University Departments, and Coordinators/Directors of University Sub-Campuses (Thane, Kalyan & Ratnagiri) are hereby informed that, as per University Circular No. **DBoEE/ICC/2025-26/1** dated **28th April, 2025**, (copy enclosed) colleges and institutions were instructed to submit the **ABC IDs of students** to the University. It was further informed that **if students' ABC IDs are not submitted, their mark sheets and degree certificates will not be issued.**

Further, as per University Circular No. **DBoEE/Exam/ICC/2025-26/13** dated **11th September, 2025** (copy enclosed), colleges were instructed to ensure that the **admission process for the Academic Year 2025–26 is carried out through the e-Samarth Portal.**

It was also informed to the colleges that, vide Circular No. **EM/ICD/2025-26/17** dated **23rd May, 2025**, (copy enclosed) students who have not generated their **ABC ID** may submit the same **within 15 days from the completion of the admission process.**

However, it has been observed that **many colleges have not yet linked their students' ABC IDs.**

All concerned colleges and institutions are directed to link **100% of students' ABC IDs** on or before **24th December, 2025. Compliance is mandatory.**

The Heads/Directors of the various Departments of the University, the Director of CDOE, and the Principals/Directors of affiliated and autonomous Colleges / Institutions in all faculties are hereby informed that, despite of the instructions given to the colleges through multiple circulars and online meetings, it has been noticed that many colleges have not yet submitted students ABC ID of all students.

The First Half 2025 (Summer) examinations are currently underway. The results of these examinations will be declared soon. As per the UGC guidelines, university has to upload credit awards and degrees on NAD Portal for accessibility of same through the National Academic Depository (NAD) and a DigiLocker systems. Therefore, having an ABC ID is mandatory for the successful upload and retrieval of these documents."

In this regard, all concerned principals of colleges and directors of institutions are hereby informed that students' mark sheets and degree certificates **will not be issued until their ABC ID is uploaded to the University's designated portal.**

Subject: NEP UG/PG Admission Process for Academic Year 2025-26 on Samarth Portal

All Principals of Affiliated Colleges, Directors of Recognized Institutions, Heads of University Departments, Autonomous Colleges/Institutions, the Director of the Centre for Distance & Open Education (CDOE), and Coordinators/Directors of University Sub-Campuses (Thane, Kalyan, Ratnagiri) are hereby informed that NEP-based UG/PG admissions for the academic year 2025-26 have commenced on the Samarth Portal.

They have to aware students about following process and give wide publicity.

After admission is granted by the College/Autonomous College/University Department as per the eligibility criteria prescribed by the University of Mumbai, the University will allocate a 16-digit Enrolment Number (ENR No.) to each admitted student.

All such admitted students will be moved to the Student Life Cycle (SLC) module on the Samarth Portal by the Department of Information Communication Technology (ICT).

Students are **compulsorily required** to complete the following steps:

6. Create a **New Password**

The Principals of the affiliated and Autonomous colleges are hereby informed that due to the non-conduct of NAAC assessment, the first-year admissions (Academic Year 2025-26) of some colleges were deactivated. However, in line with government directives as per reference no (1) and the university circular संलग्नता / आयसीसी / (२०२५ - २६) / ०५ / २०२५ दिनांक २३ मे, २०२५, (reference no 2), the deactivated admission process of the concerned colleges is reinstated with immediate effect subject to the fulfilment of guidelines given in circular (reference 2).

Colleges that have been granted an extension under the above-mentioned Government letter (Reference No. 1), shall be permitted to participate in the admission process for the academic year 2025-26.

As per University Circular No. AEM/ICC/2025-26/1(A) dated 22nd May 2025 (Reference No. 3), colleges have to carry out the admission process.

Students who have already submitted their admission forms if wish to apply for additional colleges, may generate a new application form using an alternate email ID.

Students, who have not generated their ABC-IDs are directed to do so within 15 days and update their admission profile.

The colleges are instructed to grant provisional admission to the students till they generate ABC-ID. It is the combined responsibility of the student and college to ensure that the ABC-ID of the student is generated and uploaded on the portal within 15 days.

All the concerned colleges and students are requested to take due note of the above and ensure strict compliance of this circular.
