Article 1: Objectives

Article 2: Implementation and Funding

1. **Implementation:**
 - o Specific cooperative activities under this MoU will be developed and agreed upon through subsequent agreements, which will detail the scope, objectives, timelines, and responsibilities of each Party.
2. **Funding:**
 - o The cost of cooperative activities shall be mutually determined by the Parties. Such costs will be subject to the availability of funds from both sides, and all activities will be carried out within the framework of the agreed-upon financial resources.

2. Dispute Resolution:



- o Any disputes arising from the interpretation or implementation of this MoU shall be resolved amicably through mutual consultations and negotiations.

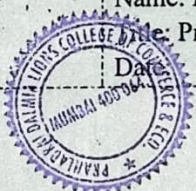
3. Governing Law:

- o This MoU shall be governed by the laws of Indore Jurisdiction.

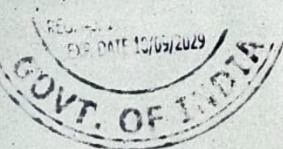
Article 6: Signatories

This MoU is executed in two originals, with each Party retaining one copy. It shall become effective upon signature by the authorized representatives of both institutions.


