Eligibility Criteria : The candidate should i) be a citizen of India (ii) should have passed 10+2 examination with eligibility as per the Admission Policy of the Affiliating University and obtained non zero score in the MAH - BCA/BBA/BMS/BBM CET-2024 conducted by the Competent Authority.

Online Registration for Admission:
