Eligibility Criteria: The candidate should i) be a citizen of India (ii) should have passed 10+2 examination with eligibility as per the Admission Policy of the Affiliating University and obtained non zero score in the MAH - BCA/BBA/BMS/BBM CET-2024 conducted by the Competent Authority.

Online Registration for Admission:

Candidates who have registered for MAH-BCA/BBA/BMS CET 2024 are not required to pay any fees for registration for admission. However other candidates who have obtained a score which is valid for admission in academic year 2024-25, CUET (UG) 2024 and have not registered for MAH- BCA/BBA/BMS CET 2024 are required to pay fees as given below only by Credit Card/ Debit Card/ Net Banking/UPI etc. through Online mode. **Fees paid are non-refundable.**
