- Bank Passbook with Aadhar Seeding.
- Self Declaration from parents.

The student those who have applied last year are required to apply under renewal scheme.

They should open a saving account in any Nationalised Bank. If they do not fill the Online Scholarship / Freeship form than they will have to pay the balance fees for the year 2020-21. The OBC/SBC/VJNT students of **B.Sc IT and BMS**, **BIM courses are not eligible for this scheme.**
